2026 SENIOR STATE AGE TRIALS

Expression of Interest

15 yrs (born 2011), 16 yrs (born 2010), 17 yrs (born 2009), 18 yrs (2008)

You are invited to attend the Burdekin Netball Association 2026 Senior State Age Trials for selection in the Burdekin Netball Representative teams to compete in the 2026 Senior State Age competition to be held at:

Townsville City Netball Association from 11th – 14th April 2026

There will be a team of 10 selected for each age group: 15 yrs, 16 yrs and 17/18 years along with training partners.

Players will be travelling on Friday 10th April (time TBA) and will return Tuesday arvo/night 14th April (time TBA).

The costs for the weekend will be approximately **\$1,000.00** (this could change once costs are finalised); this covers buses to and from Townsville, travel to accommodation and courts over the weekend and accommodation. Added to this will be the Club Netball dress, club socks and state age travel shirt and food expenses. Other club merchandise is optional. To reduce costs, fundraising prior to the event is encouraged however approval from the Burdekin Netball Management Committee must first be sought. There will be set payment dates over a period of time which must be adhered too. Payments plans can be arranged and payment **must be made in full by due date**.

Deposit of \$250.00 will be due by Sunday 19 October 2025.

All players selected are required to participate in a full season of:

15 years – Thursday afternoon juniors (compulsory) and senior competition structure (optional)

16 years – Thursday afternoon juniors or Senior Competition Structure

17-18 years – Senior Competition Structure

All players selected in the team will need to be available to participate in the following carnival and clinic. In the event you are unable to compete on this weekend, then please let the selectors know. Special circumstances will be taken into consideration and ALL interested players are urged to nominate.

As Burdekin Netball subsidises the Coaches, Manageress's, Umpires and club official/s, parents are required to clean the club house which may only be once in the year and also be involved in our Junior Carnival which date is TBA.
